was purchased and converted. With formal premises from which to operate, the Research Centre was able to expand its activities: starting the Friday lunchtime and Hersch Lauterpacht Memorial lecture series, encouraging scholars to visit from overseas and increasing its range of publications.

The Centre grew steadily over the subsequent years and with its success came a further need for expansion. In 1996 the Snyder Wing was built to provide additional study and library space, and in 2002 the neighbouring property at No 7 Cranmer Rd was acquired to provide conference and accommodation facilities. The Centre was renamed by the University of Cambridge in 1996 in honour of both Sir Hersch and Sir Eli Lauterpacht to become the Lauterpacht Research Centre for International Law - one of the most stimulating and dynamic intellectual homes for international law research in the world.

The Lauterpacht Centre for International Law, founded in 1983 by Professor Sir Elihu Lauterpacht, is the premier centre in the UK for research in the field of international law. No 5 Cranmer Road was purchased with the generous financial support of the Lauterpacht family, Dr Earl Snyder and Mr Edward St George. For the new wing in 1996, particular thanks is due to Mrs Julie Finley and Dr Earl Snyder. The premises at No 7 were purchased with generous support from the Governments of Bahrain and Malaysia and from Trinity College, Cambridge.

The general theme of the 25th Anniversary events is 'The Function of Law in the International Community'. The topic was specifically chosen to mark the 75th anniversary of Sir Hersch Lauterpacht's seminal work (1933). The formal paper on this theme will be presented at the Conference by Professor Martti Koskenniemi, Goodhart Visiting Professor at the Faculty of Law for the 2008-9 academic year.

The Centre's anniversary coincides with the 80th birthday of its founder, Sir Eli, whom will be honoured at the formal dinner in the Hall, Trinity College. Guest speakers for the dinner are Rosalyn Higgins and Stephen Schwebel, both of whom studied at Cambridge and went on to become Presidents of the International Court of Justice.

It remains to thank our Administrator, Anita Rutherford, and the Centre members who have worked tirelessly to organise these events; our speakers, moderators and rapporteurs, whose efforts and contributions are much valued; and our event sponsors, Cambridge University Press and the Foreign and Commonwealth Office, whose generous support has helped make these events possible. Speakers, delegates and other Centre friends have journeved near and far to be with us to mark this great occasion. Welcome to you all and enjoy the celebrations.

Panellist Profiles



President Gilbert Guillaume

Gilbert Guillaume was President of the International Court of Justice from 2000-2003. He was Legal Adviser to the State Secretariat for Civil Aviation (1968-1979) and the Director of Legal Affairs of the French Ministry of Foreign Affairs (1979-1987). He was the French delegate to the Sixth Committee of the General Assembly of the United Nations (1982-1987) and headed the French delegation at a number of UN Conferences, including the Third UN Conference on the Law of the Sea (1982) and the UN Conference on the Law of Treaties (Vienna, 1986). He is the President of the French branch of the International Law Association and is the author of numerous works and articles.

Professor Georges Abi-Saab

Georges Abi-Saab is Emeritus Professor of International Law at the Graduate Institute of International Studies in Geneva, Honorary Professor at Cairo University Law Faculty and a Member of the Institut de Droit International. He is currently a Member of the Appellate Body of the WTO. He has served as consultant to the Secretary General of the UN and has been appointed twice as a Judge *ad hoc* on the International Court of Justice. He was also a Judge in the Appeals Chamber of the International Criminal Tribunals for the Former Yugoslavia and Rwanda and Commissioner of the UNCC, and is a member of the Administrative Tribunal of the IMF and various international arbitral tribunals.

Professor Christine Gray

Christine Gray is a Professor of International Law at the University of Cambridge and a Fellow of St John's College. She completed a doctorate in international law at Cambridge under Clive Parry. She taught at Oxford for a decade before returning to Cambridge and St John's. Her main publications include *Judicial Remedies in International Law* (1987) and *The Use of Force in International Law* (2nd edn, 2004).

Professor Philippe Sands

Philippe Sands is Professor of Law and Director of the Centre on International Courts and Tribunals at University College, London. As a practising barrister he has extensive experience litigating cases before the International Court of Justice, the International Tribunal for the Law of the Sea, the International Centre for the Settlement of Investment Disputes and the European Court of Justice. He frequently advises governments, international organisations, NGOs and the private sector on aspects of international law. In 2003 he was appointed a Queen's Counsel. He has held numerous academic positions and has written extensively on international law issues.





Professor Francisco Orrego Vicuña

Francisco Orrego Vicuña is a Professor of Law at the University of Chile and an international arbitrator. He has presided over numerous ICSID, ICC, International Court of Arbitration, LCIA and NAFTA tribunals and *ad hoc* arbitral tribunals under UNCITRAL Rules. He is a member of the WTO panel on the dispute on subsidies between Airbus and Boeing and a member of the ICSID Chairman's list of arbitrators and conciliators. He is a loc currently a judge at the World Bank Administrative Tribunal and has been its President. He is an arbitrator with 20 Essex Street Chambers, London and has recently been President of the Institut de Droit International.

Mr Jan Paulsson

Jan Paulsson, a Senior Fellow of the Lauterpacht Centre, heads the international arbitration practice of Freshfields Bruckhaus Deringer. He has acted as counsel or arbitrator in over 400 international arbitrations in Europe, Asia, the US and Africa. He has also acted in *ad hoc* arbitrations governed by national laws and before public international law tribunals, including the International Court of Justice. He is currently president of the London Court of International Arbitration and the World Bank Administrative Tribunal. He is author of *Denial of Justice in International Law* (2005) and co-author of *International Chamber of Commerce Arbitration* (3rd ed, 2000).





Professor Martti Koskenniemi

Martti Koskenniemi is Professor of International Law at the University of Helsinki and Global Professor of Law at New York University. He was appointed as a member of the United Nations International Law Commission in 2002. From 1997-2003 he served as a judge of the Administrative Tribunal of the Asian Development Bank. He was counsellor for legal affairs at the Finnish Ministry for Foreign Affairs from 1978 to 1994. His main publications include *From Apology to Utopia*. The Structure of International Law 1870-1960 (2002) and La politique du droit international (2007).

Professor Philip Allott

Philip Allott is Emeritus Professor of International Public Law at the University of Cambridge and a Fellow of Trinity College. Formerly a Legal Counsellor in the UK Foreign and Commonwealth Office, he is the author of several publications, including *Towards the International Rule of Law: Essays in Integrated Constitutional Theory* (Cameron May, 2005); *The Health of Nations: Society and Law beyond the State* (Cambridge University Press, 2002); and *Eunomia: New Order for a New World* (Oxford University Press, 1990).





Rt Hon Lord Bingham of Cornhill

Lord Bingham of Cornhill is the Senior Law Lord. He was called to the Bar at Fountain Court Chambers and became a QC in 1972. He was appointed a High Court judge in 1980 and was promoted to the Court of Appeal six years later. He became Master of the Rolls in 1992 and was appointed as Lord Chief Justice in 1996. He succeeded Lord Browne-Wilkinson as Senior Law Lord in 2000, a position from which he is due to retire in September 2008. Lord Bingham was made a Knight of the Garter in 2005, the first judge to receive this honour. He is the Chairman of the British Institute of International and Comparative Law and also holds the office of High Steward of the University of Oxford.

Professor Christopher Greenwood

Christopher Greenwood is Professor of International Law at the London School of Economics and a barrister at Essex Court Chambers. He was previously a lecturer at the University of Cambridge. He is Joint Editor of the *International Law Reports* and has taught at universities in the United States and Germany, as well as the Hague Academy of International Law. He was called to the Bar in 1978, became a QC in 1999 and regularly appears as counsel before the English courts, the International Court of Justice and other international ribunals (including ICSID tribunals and the European Court of Human Rights). He was appointed a Companion of the Order of St Michael and St George in 2002 for services to international law.



Professor John Dugard

John Dugard recently retired as the Chair in Public International Law at Leiden University. He was Director of the Lauterpacht Centre from 1995-1997. He has been a member of the International Law Commission since 1997 and the Special Rapporteur on Diplomatic Protection to the Commission since 2000. He has been a Judge *ad hoc* in the International Court of Justice and has served since 2001 as Special Rapporteur to the UN Human Rights Council on the violation of Human Rights and International Humanitarian Law in the Occupied Palestinian Territory. His publications include *The South West Africal/Namibia Dispute* (1973), *Recognition and the United Nations* (1987) and *International Law:A South African Perspective* (2000).

Ms Elizabeth Wilmshurst

Elizabeth Wilmshurst is Associate Fellow, International Law, at Chatham House and a Visiting Professor at University College, London. She was a legal adviser in the UK Foreign and Commonwealth Office between 1974 and 2003. From 1994 to 1997 she was posted to New York as Legal Adviser at the UK Mission to the United Nations and while there led the UK delegation to the committees preparing for the establishment of the International Criminal Court. She was in the UK delegation at the 1998 Rome Conference for the International Criminal Court. She is a co-author of *Introduction to International CriminalLaw and Procedure* (Cambridge University Press, 2008) and a Companion of the Order of St Michael and St George.
