Established in 1983, the Lauterpacht Centre for International Law is the centre for the study of international law at the University of Cambridge.

In this role, it seeks to provide both a framework and forum for critical and constructive thought about the function, content and working of law in the international community, as well as to develop an appreciation of international law as an applied body of rules and principles. A number of those associated with the Centre are actively involved in the practical development and application of international law.

The Centre is not involved in the formal teaching or supervision of students of the University; this is the responsibility of the Faculty of Law, of which the Centre is part.

The Director, Deputy Directors and some of the other Fellows of the Centre, in their role as members of the Faculty, are actively involved in teaching and research supervision. The Centre provides a regular forum for lectures and seminars and other forms of small-group teaching.



The specific objectives of the Centre are:

- to serve as a discussion forum for current issues by organising seminars, lectures and meetings aimed at developing an understanding of international law;
- to promote research and publication in international law, including the publication of core research materials;
- to provide, in Cambridge, an intellectual home for scholars of international law from all over the world who wish to pursue their research in an atmosphere that is stimulating and congenial to the generation and exchange of ideas;
- to provide education and training programmes of the highest quality to external institutions under special arrangements made with those institutions;
- to maintain a library of materials relating to international law.

We are always grateful for comments and suggestions that help us improve our work.



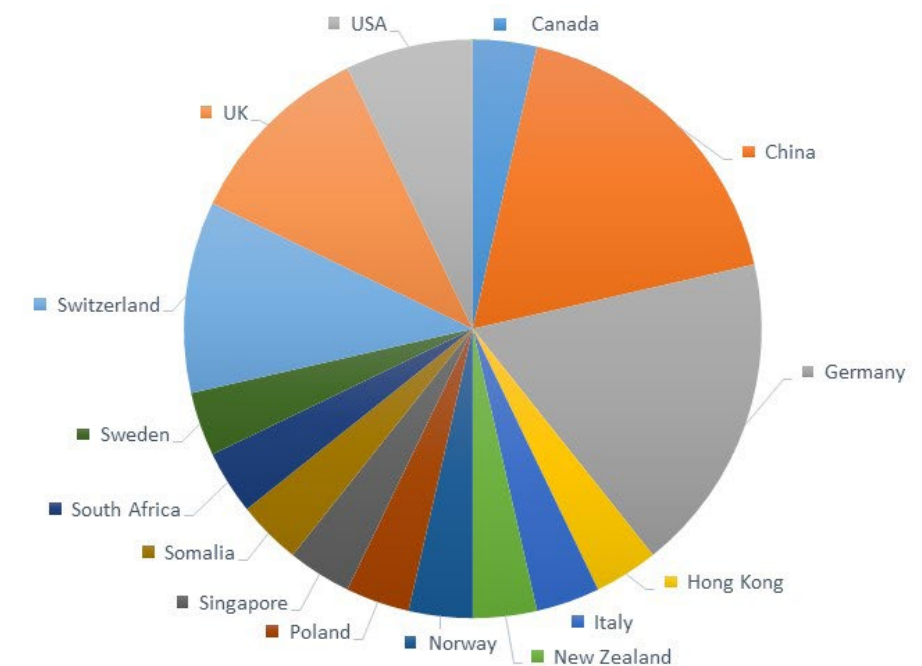

2019 –20 Highlights

The Eli Lauterpacht Lecture 2019

‘Taking Teaching Seriously: How to Teach Treaty Interpretation’

Professor Joseph Weiler, NYU Law School

11 October 2019

The Eli Lauterpacht Lecture was established after Sir Eli’s death in 2017 to celebrate his life and work, and takes place on the first Friday at the start of the Michaelmas Term in any academic year.

This year’s lecture was given by Professor Joseph Weiler, University Professor at NYU Law School and Senior Fellow at the Center for European Studies at Harvard. Until recently he served as President of the European University Institute, Florence. Prof Weiler is Co-Editor-in-Chief of the European Journal of International Law (EJIL) and the International Journal of Constitutional Law (ICON).

Lecture summary: For many years now Research & Scholarship have become the Alpha and Omega of academic life. Think of the Research Excellence Framework and the cascading effect it has had on the life of UK universities. Think of all other forms of rankings, institutional and individual, which try (miserably) to quantify quality of research, institutional and individual and the effect this has on the recruitment of staff and students and on the career paths of young scholars. Think of money -- public funding, research grants and the like and the impact this, mammon, has on academic life. Though we continue to pay lip service to the importance of teaching, nobody can question that it ranks much lower in how we rank academic excellence.

Roundtable Discussion:

‘Business and Human Rights in Domestic Courts - Contemporary Developments and Future Prospects’

6 December 2019

This well-attended panel discussion was organised and chaired by Dr Andrew Sanger, University Lecturer and LCIL Fellow.

The expert panellists discussed recent developments in UK courts, including legal and policy implications of the Supreme Court’s decision in Vedanta Resources (which paved the way for Zambian citizens to bring tort claims in English courts against UK-based Vedanta Resources) and the forthcoming Supreme Court appeal involving claims against Royal Dutch Petroleum in respect of environmental harm alleged to have been caused by its Nigerian subsidiary.

‘Human Rights and the Making of Europe: The European Court of Human Rights in the Grand Transformation’

The Sir Hersch Lauterpacht Memorial Lecture is an annual three-part lecture series given in Cambridge to commemorate the unique contribution to the development of international law by Sir Hersch Lauterpacht. Due to industrial action these lectures took place on Friday 6 March 2020 at the Lauterpacht Centre. Topics covered were:

Legalizing Free Europe: Human Rights, Cold War and the Construction of the Post-War European Legal Order (1959-89)

The ECtHR in the New Europe (1989-2009)

The End of Consensus: The ECtHR in the Age of Megapolitics (2009-2019)

Mikael Rask Madsen is a professor of European Law and Integration at the Faculty of Law, University of Copenhagen, and the founder and director of iCourts, the Danish National Research Foundation's Centre of Excellence for International Courts. Trained as a lawyer and political sociologists, his research has explores the globalization of law and the legal profession and its effects on new forms of institutions, notably international courts.

The discussions were fruitful and represented what the Lauterpacht Centre is all about: facilitating discussions among people who work on all corners of international law, and share an interest in what continues to connect all those corners.



Professor Nico Krisch awarded the first *Max Planck-Cambridge Prize for International Law (MaxCamPIL)*

On Friday 15 November 2019 Professor Nico Krisch, Professor of International Law and Co-director of the Global Governance Centre at the Graduate Institute in Geneva was awarded the first Max Planck-Cambridge Prize for International Law (MaxCamPIL) at a ceremony in Heidelberg, Germany. The Laudatio was given by Professor Eyal Benvenist, LCIL Director.

With the generous contribution of its supporting members, the Max Planck Society has established the Max Planck-Cambridge Prize for International Law (MaxCamPIL), a research prize which highlights the relevance of fundamental research in the field of international law. Its aim is to identify an outstanding mid-career legal scholar who has not only made an outstanding contribution to the study of international law but who is likely to continue to engage in substantial, innovative and cutting-edge research. It is intended to highlight and support his/her work and to provide a model of academic excellence for younger scholars.

Starting from 2019, the prize will be awarded every two years. The Selection Committee has eight members and is composed of one Director and three postdoctoral researchers from each institution. The award ceremony will take place alternately in Heidelberg and Cambridge respectively. A testimonial lecture of the winning scholar will be published in a scholarly journal of international law which will also acknowledge this prize. Within two years after the prize ceremony, the winning scholar is expected to visit one of the two institutions for a paid stay of one month. They are also expected to visit the respective other institution for a paid stay of at least five days and to hold a guest lecture or seminar.

This year's Prize Committee, chaired by Professors Anne Peters and Eyal Benvenisti, was greatly impressed by the originality, rigour and broad range of Professor Krisch's research, including original and field-defining contributions to the study of structural issues of international law, authority in global administrative law and questions of constitutional theory. Professor Krisch has made significant theoretical contributions to our understanding of governance beyond the state. His work is distinguished by his willingness to not only identify and theorise problems in international law and global governance but also to develop potential solutions. His research has strengthened the dialogue between the fields of international law, constitutional theory, and political science. Representing interdisciplinarity at its most fruitful, his work enriches international law in both substance and method.

Nico Krisch is a professor of international law and co-director of the Global Governance Centre at the Graduate Institute in Geneva.

She will be supervising many PhD students, organising seminars with fellow Public International Law Professor Neha Jain, and trying to push her research on international law and peace talks.

Moving her many boxes of books out the Centre, Sarah commented: "This unique place, the Lauterpacht Centre for International Law, has been my scholarly home for more than 15 years. The act of packing up my office has made me only more appreciative of everything the Centre has given me: collegiality, community and an enormous amount of international law, in diverse forms and shapes. In Florence I hope to develop new courses for graduate students (beginning with one on "law" in "international law" and one on editing a law journal), become familiar with academic traditions other than the beloved Cambridge one, and to enjoy the surroundings with my family. Both LCIL and the EUI attract scholars from all over the world so I hope to see many LCIL friends in the Tuscan hills. I consider this a temporary move from one paradise to another."

The Centre thanks Sarah for her wonderful contributions to the Centre and wish her the very best in her new role. We look forward to her returning to the Centre in the near future.



Dr Surabhi Ranganathan

Surabhi Ranganathan was promoted to University Senior Lecturer in October 2019, when she also succeeded Michael Waibel as a Co-Deputy Director of the Centre.

Surabhi will be on academic leave in 2020-2021, when she will spend part of the year as a Visiting Fellow at the Centre for History and Economics at Harvard University. She hopes to use the time to work on a new book, *Unmaking the Ocean*. She will jointly convene the CHE online seminar; and other workshops and events bringing together lawyers, historians, and economists.

During this period, Surabhi will continue her activities at the Lauterpacht Centre.



Dr Sandesh Sivakumaran

Sandesh joined the Lauterpacht Centre as a Fellow in the Lent Term 2020 when he took up his new position as Reader in International Law at the Faculty of Law.

Previously, Sandesh was Professor of Public International Law at the University of Nottingham and has been a non-resident research scholar at the United States Naval War College Stockton Center for International Law and has held visiting fellowships at Melbourne Law School and New York University School of Law.

Sandesh regularly trains diplomats, members of the armed forces, and UN entities on international law and the law of war. He is a member of the Bar of the State of New York. Sandesh holds an MA and PhD from the University of Cambridge and an LLM from New York University School of Law where he was a Hauser Global Scholar.

Sandesh takes over from Dr Sarah Nouwen as Co-Deputy Director of the Centre when she takes up a new position in Florence in September 2020.

Friday Lunchtime Lecture Series

International Law and Political Engagement (ILPE) Series

During the last year, two International Law PhD students, Francisco José Quintana and Marina Veličković, organised a series of conversations held at the Centre. These were based on international legal scholarship, political engagement and the transformative potential of academia. Chaired by Francisco and Marina themselves each conversation centres around a theme, concept or a method and their relationship to political movements, struggles and margins from which they have emerged and within (and for) which they have emancipatory potential. All events - the first two at the Centre, and the third online were very well attended.

16 January 2020 - In Conversation with Gerry Simpson: On the Politics of Method

Speaker: Professor Gerry Simpson was appointed to a Chair in Public International Law at the LSE in January, 2016. He previously taught at the University of Melbourne (2007-2015), the Australian National University (1995-1998) and LSE (2000-2007) and has held visiting positions at ANU, Melbourne, NYU and Harvard.



5 February 2020 - In Conversation with Dr Luis Eslava: On International Law and the South - Luis Eslava, Kent Law School

Speaker: Dr Luis Eslava is a Reader in International Law and Co-Director of the Centre for Critical International Law at Kent Law School. He also holds visiting positions at Melbourne Law School and Universidad Externado de Colombia, and teaches regularly at Harvard Law School's Institute for Global Law and Policy Workshops.



19 June 2020 - In Conversation with Dr Robert Knox and Dr Ntina Tzouvala: 'On International Law and Critique in time of COVID-19'

Speaker: Ntina Tzouvala is an ARC Laureate Postdoctoral Fellow in International Law at Melbourne Law School. Her work focuses on the history and theory of international law, with a particular emphasis on international law and global capitalism.



Speaker: Robert Knox is a Senior Lecturer in Law at the University of Liverpool and an Editor of Historical Materialism and The London Review of International Law. He works primarily in the Marxist and critical legal traditions. His research touches on the relationship between international law, capitalism and imperialism (with a particular focus on questions of racialisation), on law's key role in the birth and consolidation of neoliberalism and on the relationship between law and social change.



Legal Histories Beyond the State Seminar Series

In collaboration with the Centre for History and Economics and the Cambridge Centre for Political Thought, this series of seminars brings together historians, political theorists and lawyers who are interested in the social, economic and political dimensions of law in the modern period. The series is convened by Dr Surabhi Ranganathan, Co-Deputy Director of the Centre.

Hosted at the Centre, these seminars focus on the ways in which law and legal institutions order and organize space and people. This encompasses both imperial and international law, and domestic public and private law in its manifold influences on the nature and form of relations across borders.

In bringing together scholars from a wide range of disciplinary, methodological and geographic orientations, the series aims to strengthen and enrich the work being pursued in these disparate fields, but also test the limits of existing perspectives and lay the foundations for more fluid and productive interactions between them.

Some sessions are devoted to discussion of new, published work in the field, and others to the sharing of works-in-progress, whether draft articles, chapters or book prospectuses, with a core group of scholars from a variety of disciplines.

In the academic year 2019/20, the following sessions took place at the Centre. Megan Donaldson (UCL) and Annabel Brett (Cambridge; Centre for Political Thought) were co-conveners.

Evening Lecture: ‘Law and Politics in the UN Climate Regime: A Preview of the Santiago Climate Conference’ - Daniel Bodansky, Regents’ Professor at Arizona State University’s Sandra Day O’Connor College of Law.

Thursday 7 November 2019

Is implementation of the Paris Agreement on track? What are the Agreement’s prospects for success? The talk will review developments in the international climate change regime, including the recently concluded UN Climate Change Summit, analyze the state of play in the UNFCCC regime, and preview the upcoming conference of the parties (COP25) in Santiago in December.

Commander Ian Park (Royal Navy International Law Legal Adviser) will offer a view on the role of the military legal adviser during armed conflict and peacetime military operations. He will consider recent armed conflicts in Iraq, Libya, Afghanistan, and Syria, and Royal Navy peacetime military operations in the Arabian Gulf, Indian Ocean and Mediterranean.

CUArb/LCIL Inaugural Arbitration Lecture: ‘Cyber-security and the future of the obligation of full protection and security in investment law’ - Richard O’Brien, 4 New Square

Wednesday, 12 February 2020

Cyber-attacks on large organisations, including multi-national companies, have increased in number and severity in recent years. This lecture explores what that means for the obligation of full protection and security commonly found in bilateral investment treaties (BITs). Existing debates about whether it encompasses physical harm only or also legal risk may need to be updated. They should ask also whether States’ unique capacity, and in some cases assumption of responsibility, to guard against cyber-risks may expose them to claims by investors under BITs for preventable damage done to their investments by cyber-attacks.

International Law Reports (ILR)

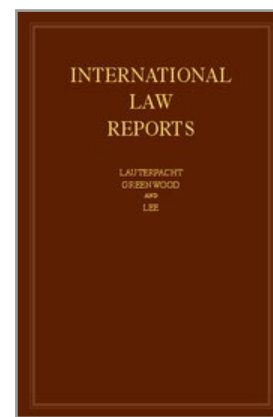

The International Law Reports (ILR) have been reporting the decisions of national and international courts and tribunals on issues of public international law for over ninety years.

The series captures the full range of judgments and awards on issues of international law from the increasing number of international courts and tribunals while expanding coverage of national judgments.

Volumes 183 to 187 were published in print from 1 October 2019 to 30 September 2020, and the series is available online via Cambridge Law Reports (CLR) as well as Justis.

International Convention on the Settlement of Investment Disputes Reports (ICSID)

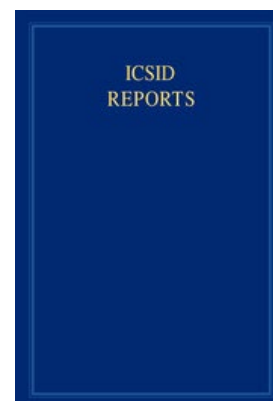
The International Convention on the Settlement of Investment Disputes (ICSID) Reports detail cases decided under the Convention on the Settlement of Investment Disputes between States and Nationals of Other States 1965, and related decisions on international protection of investments. The Reports are currently edited by Professor Jorge Vinuales and Professor Michael Waibel.

An international dispute settlement system which is of great and growing importance, the reports are now presented in these volumes in consolidated form for the first time, together with materials related to ICSID cases from national courts around the world.

All the decisions are presented in English with summaries, and are translated from other languages where necessary. These reports are an invaluable working tool for lawyers and scholars working on international investment issues and in international arbitration.

Scholarships

Brandon Research Fellowship 2019/20

The Brandon Research Fellowship 2019/20 was awarded to Ms Maryan Hassan, Chief Trade Negotiator & Head of Arbitration of the Office of the President of Somalia.

Unfortunately, due to the COVID-19 pandemic, Ms Hassan was not able to attend the Centre in person but worked remotely on her research project: *Developing a suitable investment arbitration regime for a post-conflict G7+ state: the case for Somalia*. We hope that she will be able to visit the Centre in person in the future.



The Fellowship is worth £4,500 and is funded by generous gifts by the late Mr Michael Brandon and his son, Mr Christopher Brandon. It is intended that the award cover a visit to the Centre of about 12 weeks; guidelines on eligibility are posted alongside the call for applications.

Polonia Scholarship in International Law 2019/20

The 2019 Polonia Scholarship holder was Prof Marcin Menkes from the Warsaw School of Economics, who visited the Centre during the Michaelmas Term 2019. His research project at the Centre concerned *Governance of International Investment Flows in the Age of Postmodernity*.

The Polonia Scholarship is funded by a private gift to the Centre. The scholarship is worth £2,000 and is intended to fund a visit at the Centre of between 4 and 13 weeks. It is open to scholars of Polish or Israeli citizenship.



Silk Road Scholarship

The 2019–20 Silk Road Scholarship was awarded to Dr E-Nuo Gu, Assistant Professor at Xi'an Jiaotong University's School of Law, for research on *A Study on the Latest Development of the Position of ISDS Reform in BRICS and China's response*.

Dr Gu arrived in December 2019 for a 12 month visit, and is the seventh Silk Road Scholar to be welcomed at the Centre, under an agreement with Xi'an Jiaotong University.



Snyder Scholarship 2019/20

The recipient of this year's Snyder Scholarship was Ms Sabienne Brutus, a recent graduate of Indiana University Maurer School of Law.

Ms Brutus worked on her research project Understanding lending contracts between the International Monetary Fund and the World Bank and small sovereign states whilst at the Centre from September to December 2019.

The Snyder Scholarship runs alongside the Snyder Lectures, which are held in memory of Dr Earl Snyder, a 1947 Indiana University law graduate. The visiting scholarship and lecture series form a partnership between the Lauterpacht Centre and the Indiana University Maurer School of Law.



Bohdan Winiarski Scholarships in International Law 2021

The two Bohdan Winiarski scholarships are funded by the Embassy of the Republic of Poland in the United Kingdom of Great Britain and Northern Ireland. The scholarships are named after the Polish Judge and international lawyer, Bohdan Winiarski.

Each scholarship has a value of £2,600 and is intended to support the costs of a research visit of at least 8 weeks at the Centre. Applications are open to nationals of the Visegrad Group States and Western Balkans States (one scholarship) and Eastern Partnership states (one scholarship).

Due to the pandemic, recipients of the 2020 scholarships have deferred taking up their award until 2021. The closing date for the 2021 Scholarship was extended to 31 July 2020; applications are currently under review.



BRCS/ICRC Customary International Humanitarian Law Project

The research team working on the project on Customary International Humanitarian Law (IHL) of the British Red Cross and the International Committee of the Red Cross (ICRC), which the Lauterpacht Centre has hosted since its start in 2007, has enjoyed another successful year at the Centre.

The project provides geographically diverse information in the field of international humanitarian law (IHL) by up-dating the practice part of the ICRC's award-winning online Customary IHL Database.

The Database contains the 161 rules of customary IHL identified in the ICRC's 2005 Customary HL Study and the practice underpinning these rules. Its aim is to provide accurate and extensive information in the field of customary IHL and to make this information readily accessible to people and institutions interested in, or dealing with, IHL and armed conflict. The Database covers national practice of States from all over the world, from Afghanistan to Zimbabwe, as well as practice found in international materials. The research team at the Lauterpacht Centre focuses on the analysis of national practice, while, since 2014, researchers based at Laval University in Canada have concentrated on up-dating international materials.

In the 2019–2020 academic year, new practice analysed by the research team at the Lauterpacht Centre was published for Djibouti, covering the years 2013–2017. Moreover, while the practice section continues to make worldwide practice available in English, in December 2019, the rules section of the database was made available in six additional languages: Arabic, Chinese, French, Portuguese, Russian and Spanish.

The year also brought some changes in the research team. In January 2020 the team said farewell to Hannah Maley as she moved on to new endeavours after being with the project for three years, while in August it welcomed Ms. Antoana Nedyalkova, who joined the project as a researcher. The team was also pleased to celebrate the fifth anniversary of Claudia Maritano with the project, the first two years as researcher, and now as team leader. The team also celebrated Emilie Fitzsimons' third anniversary as researcher, as well as Silvia Scozia and Francesco Romani's second anniversary with the team.

Lauterpacht Linked Partnership Programme

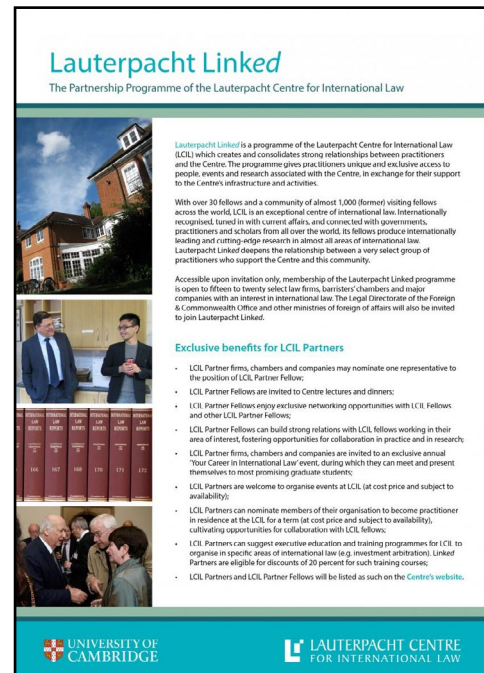

Advisory Board
