Established in 1983, the Lauterpacht Centre for International Law is the centre for the study of International Law at the University of Cambridge.

In this role, it seeks to provide both a framework and forum for critical and constructive thought about the function, content and working of law in the international community, as well as to develop an appreciation of international law as an applied body of rules and principles. A number of those associated with the Centre are actively involved in the practical development and application of international law.

The Centre is not involved in the formal teaching or supervision of students of the University; this is the responsibility of the Faculty of Law, of which the Centre is part.

The Director, Co-Deputy Directors and some of the other Fellows of the Centre, in their role as members of the Faculty, are actively involved in teaching and research supervision. The Centre provides a regular forum for lectures and seminars and other forms of small-group teaching.

The reception of visitors from around the world is a key aspect of the Centre's activity. Visiting academics and PhD candidates are welcomed for periods varying from one term to a year.

#### The specific objectives of the Centre are:

- at developing an understanding of international law;
- materials;
- and exchange of ideas;
- to provide education and training programmes of the highest quality to external institutions under special arrangements made with those institutions;
- to maintain a library of materials relating to International Law.

### **Director's Foreword**

At the beginning of this period the UK was still operating under COVID pandemic restrictions. Staff were allowed to return to work at the Centre on the proviso they adhered to the social distancing rules currently in place at that time. As a result, the Centre was able to accept a limited number of visiting fellows in person.

All Centre events and lectures remained online during this period which enabled us to continue to reach out to various audiences from around the world and without losing our local fellows and students. The Friday Lunchtime Lectures began with the annual Eli Lauterpacht Lecture 2021 with Dame Sally Davies, The UK Government's Special Envoy on Antimicrobial Resistance (AMR) and Chair of the Trinity Challenge. Prof Ranganathan's series of workshops – Law & Society in History: Mobilities, Scales, Methods (a joint initiative with the Centre for History and Economics, University of Cambridge and Harvard University) continued as hybrid events as restrictions began to be relaxed. The Art, Architecture and International Law seminar series chaired by Prof Sivakumaran continued online in Easter term. Student-led online lectures, as organised by PhD students of the Cambridge University Arbitration Society (CUArb) continued for a second year.

Building work on a new seminar room, adjacent to the Finley Library, was completed during the spring of 2022. The new space was made possible through a generous donation by Dr Ivan and Mrs Francesca Berkowitz, long-standing friends and benefactors of the Centre. An official opening of the seminar room is planned for 6 October 2022. The new room, which will be known as the Dr Ivan and Mrs Francesca Berkowitz Seminar Room, will benefit from new technology enabling the Centre to livestream lectures and events from January 2023.

Despite the limited capacity and social distancing rules in place during the autumn of 2021, we are pleased to report that we were able to host 32 Visiting Fellows from around the world from 1 October 2021 to 30 September 2022. (see Appendix I).

In June 2022 we were also delighted to welcome Zarine Russell as Centre Coordinator. Zarine joins us from the Foreign, Commonwealth and Development Office and will work with Karen Fachechi and Vanessa Bystry to continue the administrative and practical service in the day-to-day running of the Centre. We are very grateful to the Law Faculty, in particular Laura Smethurst, Joseph Clements and Elizabeth Aitken, for their support and assistance following the retirement of Anita Rutherford in January 2022.

We are always grateful for comments and suggestions that help us improve our work.



### **Memorial Conference: Judge James Crawford**

A memorial conference for HE Judge James Crawford titled Teacher, Scholar, Lawyer, Judge: Celebrating James Crawford was held on Sunday 29 May 2022 at the Faculty of Law.

James served as a Judge at the International Court of Justice, a member of the International Law Commission, as a Whewell Professor of International Law at the University of Cambridge, and as a Director of the Lauterpacht Centre of International Law from 1997 to 2003 and from May 2006 to September 2010.

The conference was organised by the Lauterpacht Centre in collaboration with the Law Faculty. Over 160 participants from the field of international law attended and the event concluded with a BBQ Reception in the Centre's gardens.

#### The Eli Lauterpacht Lecture 2021 Online

'Global Governance for Health - why has it failed?'

Dame Sally Davies, The UK Government's Special Envoy on AMR and Chair of The Trinity Challenge

8 October 2021

In this lecture Dame Sally explored global governance for health using the two pandemics of COVID-19 and Antimicrobial Resistance (AMR) as exemplars highlighting the importance of data and innovation.

Dame Sally Davies is the 40<sup>th</sup> Master of Trinity College, Cambridge University, the UK Government's Special Envoy on AMR and the chair of The Trinity Challenge, which she set up in May 2020.

#### Hersch Lauterpacht Memorial Lectures 2022

This lecture series normally takes place in March each academic year. However, due to COVID restrictions and speaker availability this was unable to take place in March 2022.

### Lectures & Events

Many of the Centre's lectures and events were recorded and made available on the University Streaming Service.

#### **Friday lunchtime lecture series**

The Centre's regular Friday lunchtime lecture series on topical issues in international law by leading academics and practitioners continued on Zoom.

#### Art, Architecture and International Law seminar series

This lecture series is designed to bridge the worlds of art, architecture and international law. It explores the different ways in which art and architecture and international law intersect. It also demonstrates that international law exists well beyond the written word.

The lecture series is organised by Centre Co-Deputy Director, Prof Sandesh Sivakumaran.

### Law & Society in History - Mobilities, Scales, Methods

This lecture series is part of the Global Legal Histories Series, Joint Centre for History and Economics, University of Cambridge and Harvard University and the Lauterpacht Centre and co-organised by Prof Surabhi Ranganathan.

Law & Society in History: Mobilities, Scales, Methods puts a spotlight on exciting new research that interrogates confluences and encounters between law, society and history, drawing law and society, legal history, and international law scholars into discussion about methods, mobility, and scales.

Each seminar invites authors to place their new work in conversation with ongoing debates about the social and political dimensions of law, about appropriation, subversion, translation and transformation, and about the relationship between law and human behaviour. The focus is on elaborating over the series a range of conceptual and methodological contributions to these debates.

### **Cambridge University Arbitration (CUArb) series**

The Cambridge University Arbitration (CUArb) series aims at promoting the study of international commercial and investment arbitration amongst students, academics, alumni and law practitioners. It seeks to serve as both an educational and networking platform to facilitate discussions on emerging topics in international arbitration and connect students with practitioners.

The student-led CUArb society runs a series of lectures each term in cooperation with the Lauterpacht Centre. These lectures discuss the current hot topics in both international commercial and investment arbitration.

Periodically, CUArb organises discussion panels to address some of the pressing issues in international arbitration. These lectures and panels are given by academics, judges, arbitrators and practitioners. The CUArb also organises an annual conference besides the Cambridge Arbitration Day each year.

#### **Awards & Scholarships**

#### **Centre Fellow Jamie Trinidad receives Round Table Peter Lyon Prize**

Jamie Trinidad, Fellow and Director of Studies in Law at Wolfson College, and Fellow of the Centre, was awarded the prestigious Round Table Peter Lyon prize for his article "Self-determination and contested peoplehood in Gibraltar: separating the law from the rhetoric", published in the June 2021 issue of The Round Table: The Commonwealth Journal of International Affairs.

Founded in 1910, The Round Table is the oldest English-language international affairs journal, and provides analysis and commentary on all aspects of international relations. The journal is the major source for coverage of the policy issues concerning the contemporary Commonwealth, with occasional articles on themes of historical interest.

The Peter Lyon prize is an annual prize for the best policy-oriented article on a theme of significance for the contemporary Commonwealth published in the journal each calendar year.

#### Andrew Sanger wins Cambridge Student Union Award for Teaching

Associate Professor of International Law and Centre Fellow, Andrew Sanger, was the recipient of an award from the Cambridge Students Union Student-Led Teaching Awards (SLT) earlier this year.

The SLT awards exist to reward outstanding teaching and student support across Cambridge. This year, the SU received just under 400 nominations, which truly is a testament to all the amazing work done by university staff and clearly demonstrates the gratitude felt by students.



#### **Brandon Fellowship**

The Brandon Research Fellowship was funded by a generous gift in 2009 by the late Mr Michael Brandon and his son, Mr Christopher Brandon.

The successful candidate for the Brandon Fellowship this year is Dr Carlo de Stefano from Roma Tre University, Italy. The title of his research is *A human rights-based perspective on State immunity from Execution*. He will visit the Lauterpacht Centre in 2023.

#### Polonia Scholarship

The Polonia Scholarship is funded by a private gift to the Centre and is open to scholars of Polish and Israeli citizenship, especially those who are in the early years of their career. The successful candidate for 2021-2022 was Dr Omri Sender who visited the Centre in January 2022 to carry out independent research on Assembling a repository of analysis and information on both the law and practice of two recognised international dispute settlement means: arbitration and judicial settlement.

#### **Snyder Scholarship**

The Snyder Scholarship runs along side the Snyder Lectures which are held in memory of Dr Earl Snyder, a 1947 Indiana University law graduate, and form a special partnership between the University of Cambridge and the Indiana University Maurer School of Law.

The successful candidate for the Snyder Scholarship 2022 is Ms Kacey Bengel, from Maurer Law School, University of Indiana. Kacey will visit the Lauterpacht Centre in the Michaelmas Term 2022 and will carry out research relating to *asylum law*.

#### **Bohdan Winiarski Scholarships**

The Bohdan Winiarski scholarships are funded by the Embassy of the Republic of Poland in the United Kingdon of Great Britain and Northern Ireland, and named after the Polish Judge and international lawyer, Bohdan Winiarski.

The successful candidates for the Winiarski Scholarships 2021-2022 are:

Mr Paolo Marshyn, a PhD student from the Belarusian State University, who will visit the Centre in September 2022. His research topic relates to *Attribution of Conduct of Non-State Actors to the State in International Law.* 

Dr Tamás Hoffmann, senior research fellow at the Hungarian Academy of Sciences Centre of Excellence, Budapest, Hungary who will visit the Centre in 2023. His research topic relates to *Domestication of Internatinal Law in Action: The Hybridization of International Criminal Norms*.

Dr Farid Turab Ahmadov, assistant professor at the ADA University, Baku, Azerbaijan who will visit the Centre in 2023. His research topic relates to: *The Concept of Compelling Reason in the Advisory Proceedings of the International Court of Justice*.

#### **New Fellows of the Centre**

The Centre warmly welcomes the following new Fellows of the Centre:

Nafay Choudhury is a Junior Research Fellow at St. Catharine's College and Associate Member of the Centre for Global Knowledge Studies.

His research explores the fragmented and plural forms of order that exist within the state, alongside the state, and beyond the state. His current research looks at the role of market associations in providing normative order in fragile settings. As a socio-legal researcher, he is interested in understanding how global legal norms, such as those promoted by international organizations, take shape at the local level.

Nafay's research interests include socio-legal studies, legal pluralism, economic development, and the rule of law.

**Orfeas Chasapis-Tassinis** is as a Research Fellow at Gonville and Caius College and an Associate Editor for the European Journal of International Law.

He holds law degrees from the Universities of Thessaloniki (LLB), Athens (LLM) and NYU (LLM), where he was awarded the Jerome Lipper Prize for International Law. In 2020, Orfeas completed his PhD as a WM Tapp and AHRC scholar at Caius. His thesis, entitled 'Revisiting the Theoretical Foundations of International Organizations in Public International Law, was awarded a Yorke Prize by the Faculty of Law in 2021. Before re-joining Cambridge as a Research Fellow, Orfeas was a Max Weber Fellow at the EUI.

He is currently working on a book project on the legal theory of international organizations, as well as an article on international lawyers' analytical modelling of customary international law.

Stefan Theil is the John Thornley Fellow in Law at Sidney Sussex College.

He completed his first degree in law at the University of Bayreuth (2011) in Germany. After brief stints working for a commercial law firm in Munich and for the Research Services of the German Bundestag in Berlin, Stefan earned an LLM from University College London (2013). Inspired to pursue a career in academia, he completed his doctoral work at the University of Cambridge (2018) and was the inaugural Research Fellow in Civil and Political Rights at Bonavero Institute, University of Oxford (2017-2021).



The research team working on the Project on Customary International Humanitarian Law of the British Red Cross and the International Committee of the Red Cross (ICRC), which the Lauterpacht Centre has hosted since its start in 2007, has enjoyed another successful year at the Centre.

The project provides geographically diverse information in the field of international humanitarian law (IHL) by up-dating the practice part of the ICRC's award-winning online Customary IHL Database. The Database contains the 161 rules of customary IHL identified in the ICRC's 2005 seminal Study and the practice related to these rules. Its aim is to provide accurate and extensive information in the field of customary IHL and to make this information readily accessible online. The Database covers national practice of States from all over the world, from Afghanistan to Zimbabwe, as well as practice found in international materials. The research team at the Lauterpacht Centre focuses on the analysis of national practice, while, since 2014, researchers based at Laval University in Canada up-date international materials.

In the 2021–2022 academic year, the database was up-dated with new practice from five States: Georgia for the years 2015-2017, South Africa for the year 2014, Sri Lanka covering the years 2011–2014, Uruguay for the years 2008-2014 and Zimbabwe for the year 2016. While the practice section continues to make worldwide practice available in English, since December 2019, the rules section of the database has been available in six additional languages: Arabic, Chinese, French, Portuguese, Russian and Spanish. In 2021, the database was accessed over a million times, for the second year in a row.

The research team also engaged in dissemination activities, with presentations delivered to the Lauterpacht Centre visiting fellows and PhD students, as well as to British Red Cross colleagues. These represented valuable opportunities to promote the Database and the Study to the academic community and colleagues alike.

The year also brought some changes in the research team. In December 2021, the team said farewell to Natascha Kersting, who moved on to new endeavours after working on the Project for just under a year. The team also celebrated Juliano Simões-Ferreira's first anniversary with the Project, Antoana Marinova-Nedyalkova's second anniversary, as well as Emilie Fitzsimons' fifth anniversary. Finally, we are pleased to announce the addition of two new researchers to the team. These are Andrea Farrés Jiménez, who joined in September 2021, and Juliette Rémond Tiedrez, who came on board in February 2022.

#### International Law Reports (ILR)

The International Law Reports are edited by Sir Christopher Greenwood GBE CMG QC and Karen Lee, Centre Fellow and Fellow and former Vice-Mistress of Girton College, Cambridge.

The International Law Reports (ILR) have been reporting the decisions of national and international courts and tribunals on issues of public international law for over ninety years.

The series captures the full range of judgments and awards on issues of international law from the increasing number of international courts and tribunals while expanding coverage of national judgments.

Volume 199 was published in September 2022. The series is also available online via *Cambridge Core* as well as Justis.

#### International Convention on the Settlement of Investment Disputes Reports (ICSID)

The ICSID Reports are edited by Professor Jorge Viñuales, Fellow of the Centre, and Professor Michael Waibel, formerly co-Deputy Director of the Centre.

The International Convention on the Settlement of Investment Disputes (ICSID) Reports provide an authoritative published collection of investor-State arbitral decisions rendered under the auspices of the World Bank's International Centre for Settlement of Investment Disputes (ICSID), pursuant to other bilateral or multilateral investment treaties such as the North American Free Trade Agreement (NAFTA) and the Energy Charter Treaty (ECT), or involving investment contracts entered by States.

Combining analytical studies with case summaries by practitioners, the ICSID Reports are an invaluable tool for those working in the field of public international law, investment treaty arbitration, or international commercial arbitration, whether advising foreign investors or States. All 20 volumes are available in hard copy and online at Cambridge Core. Three thematic volumes have been published:

Volume 18: Defence Arguments in Investment Arbitration (Cambridge University Press, 2020) Volume 19: The Meaning of Investment (Cambridge University Press, 2021) Volume 20: Attribution of Conduct to the State (Cambridge University Press, 2022)

Each volume has featured an eminent guest contributor, including Jan Paulsson, Christoph Schreuer, and Meg Kinnear. The next three volumes, under preparation, will focus on remedies (Volume 21), climate change and sustainability (Volume 22), and European Union law (Volume 23) in investment arbitration.
