We are grateful to Sir Elihu Lauterpacht for having conceived this lecture program and to Sir Michael Wood for his excellent contribution to the series.

As the Michaelmas term draws to a close, we also look forward to welcoming former LCIL Director **Daniel Bethlehem** back to give the last Friday talk of the term on "*The role of the FCO Legal Adviser: first impressions.*" Although the term is ending, work at the Centre continues with the revamp of the Centre's website, planning for upcoming programs and preliminary planning for the celebration of the Lauterpacht Centre's 25<sup>th</sup> anniversary in 2008. Coinciding with Sir Elihu Lauterpacht's 80<sup>th</sup> birthday, we hope that the Centre's supporters, former fellows and friends will hold 11<sup>th</sup> and 12<sup>th</sup> July 2008 for a celebration in Cambridge of these two milestone events. There is much to report from the Centre this month:

- ▶ Congratulations to **Dr Roger O'Keefe**, the Centre's deputy director, on the publication of his new book "*The Protection of Cultural Property in Armed Conflict*". The book, published by CUP as part of the *Cambridge Studies in International and Comparative Law* series is available from the [CUP website](#).
- ▶ Centre Publications:
  - **Volume 128** of the **International Law Reports** is due to be published in early December and includes the arbitral decisions and award and US decision in the *Loewen* case; the award in arbitration between *Newfoundland and Labrador and Nova Scotia* concerning Portions of the Limits of their Offshore Areas; and *state immunity* cases from Belgium, Canada, England, France, Germany, Italy, the Netherlands, Spain and Sweden.
  - **Volume 10** of the **ICSID Reports** is due to be published on 14<sup>th</sup> December and includes the awards in *Zhinvali v. Georgia*; *Semos v. Mali*; *Tecmed v. Mexico*; *Generation Ukraine v. Ukraine*; *Autopista v. Bolivia*; the decisions in *Fireman's Fund v. Mexico*, *Champion Trading v. Egypt* and *Azurix v. Argentina*; and the last two decisions in the *Loewen* saga.

- ▶ The Centre has received confirmation that, as part of the Faculty of Law, it is authorised by the Law Society of England & Wales to issue **Continuing Professional Development (CPD) credits** to solicitors attending its Friday Lunchtime and other *ad hoc* public lectures. This accreditation not only raises the Centre's external profile but recognises the quality and expertise of the speakers on the Centre's lecture program to whom we are indeed indebted. Similar recognition is also expected in due course from the Bar Council.
- ▶ The **Friday Talks Program** continued in November with:
  - Professor Theunis Roux on land restitution and reconciliation in South Africa;
  - Sir Michael Wood discussing his three-part Hersch Lauterpacht Memorial Lecture on the UN Security Council and international law;
  - Rt Hon Sir Ian Barker on Fiji – the coup and the constitution; and
  - Professor Carmen Gonzalez on markets, monocultures and malnutrition: agricultural trade policy through an environmental justice lens
- ▶ The **Visiting Fellows Roundtable** featured presentations by **Giulio Bartolini**, University of Roma Tre, Italy on reparation for violations of human rights; **Annemarieke Vermeer-Kuenzli**, Leiden University, The Netherlands on reconciling the invocation of responsibility *erga omnes* and diplomatic protection; and **Michael Waibel**, Universität Wien, Austria on Sovereign Bonds in International Arbitration. **Judith Welling**, this year's Snyder Scholar, will present on indicators and economic, social and cultural rights at the next Roundtable on 7<sup>th</sup> December.
- ▶ **People at the Centre** The end of November saw the departure of **Thomas Schultz** who left after a productive year at the Centre during which he published two books: *Information Technology & Arbitration: a practitioner's guide* (Kluwer, 2006); and *Réguler le commerce électronique par la résolution des litiges en ligne* (Bruylant, 2005). Thomas returns to Switzerland as a Senior Research Fellow at Geneva University's Faculty of Law. Also leaving us is **Giulio Bartolini** of the University of Roma Tre, who returns to Italy after a two-month stay at the Centre. To the Centre, we welcome:
  - **Michael Waibel** is a PhD candidate at the Universität Wien, Austria and teaches classes in European Economic Policy at the London School of Economics. His thesis, supervised by August Reinisch, deals with public debt and sovereign insolvency in international law.
- ▶ **Alumni News** Congratulations to Jeffrey Dunoff, who was a visiting fellow at the Centre in 2005, on the publication of his paper "Constitutional Conceits: The WTO's 'Constitution' and the Discipline of International Law" in the *European Journal of International Law* (EJIL (2006), vol. 17 No. 3, 647 – 675)
