News from Fellows and Alumni:

Margaret Young has been appointed Assistant Editor of the *British Yearbook of International Law*. Margaret joined Pembroke College as the William Charnley Research Fellow in Public International Law in 2007, a position that is jointly funded by a generous private donor, the College's Thornton Law Fund and the Lauterpacht Centre for International Law.

Vuyelwa Kuuya is a research fellow of the Lauterpacht Centre and a research associate of First Africa (Ltd). She is working on the joint First Africa (Pty) Ltd and Lauterpacht Centre Project on Corporate Complicity. She is a graduate of the University of Cape Town (LLB) and University College London (LLM). Her research interests also include the justiciability and privatisation of the provision of socio-economic rights, indigenous rights in natural resource extraction, international sustainable development law, international terrorism law and Alternative Dispute Resolution.

Elies van Sliedergt, a former Visiting Scholar, writes:

"I have been awarded the Giorgio la Pira Prize 2007 for the best paper by a 'young scholar' in the *Journal of International Criminal Justice* (a prize Roger O'Keefe won in 2005). The article was written during my 3 month stay as a visiting fellow at the Lauterpacht Centre (Lent Term 2006). The Centre's working environment contributed hugely to the quality of my work. This is why I thought I should pass on the news."

Professor Dobrochna Bach-Golecka, who was a Visitor at the Centre in 2002, has donated to the Centre's Library a copy of her book (in Polish) *Democracy in International Law*. She writes that her time here was essential to completing it.

Professor AF Maniruzzaman, a former Visiting Fellow of the Lauterpacht Centre and currently Professor of International and Business Law, University of Portsmouth, has been elected Visiting Professor of Law (in the academic year 2007/8) at the Faculty of Law, University of Western Ontario. He has also been elected a Council Member of the International Chamber of Commerce Institute of World Business Law, Paris.
